

GRANTS & LOANS University Of California, Riverside 2011-2012

The Chicano Educational & Cultural Fund, Inc. (CECF) has established a Grant and Loan Assistance program to support students, staff, and faculty pursuing academic and career endeavors at the University of California, Riverside.

GRANT GUIDELINES

Grant awards are available in the amount of \$150 to UCR students, staff, and faculty participating in the following:

- Conferences, workshops, cultural events, and activities of interest to the UCR Chicano/Latino community
- Conferences, workshops, cultural events, and activities which will assist the applicant in obtaining skills for current or future job opportunities
- Graduate preparation seminars offered through the UCR Learning Center

The selected applicant will be required to submit a written report about the completed activity or make a personal presentation at a CECF, Inc. Board Meeting.

LOAN GUIDELINES

Loan awards are available in the amount of \$150 for full time registered UCR students. Loans can be utilized for any of the following:

- Tuition
- Books and classroom supplies
- Housing associated costs

At the time of application, the applicant must be:

- A registered UCR student
- Enrolled in at least ten (10) units
- In good academic standing, and
- Completed at least one quarter at UCR.

Loan Applicants: Students can only receive ONE loan per year and cannot have any outstanding unpaid loans to CECF, Inc. or any other UCR Association. All applicants must first seek funds through the Emergency Loan Program at the UCR Financial Aid Office before being considered for a CECF, Inc. loan. Upon approval, arrangements will be made with CECF, Inc. for repayment of a loan.
